Above costs are for transportation only and do not include negotiated Group Lessons (if applicable), Stevens Pass lift tickets, or Equipment Rentals.

Parents must provide for these separately! Lessons and Lift ticket must be purchased from Steven's Pass Ski Resort by November 30, 2018.

Participation Agreement & Liability Release

I/we recognize that snow sports activities are hazardous and could result in serious injury or death. I/we understand helmets are mandatory in this program. I/we understand and agree that I/we may be riding the chairlifts with a student, instructor, a member of the public or I/we may be riding the lift alone. I/we have voluntarily made a choice to participate in this activity and accept the inherent risks. I/we accept my/our responsibility to be informed, behave prudently, and to read and abide by the Responsibility Code and all other posted behavior notices in these sports and in the ski area/mountain environment. I/we agree to **Release, Forever Discharge, Defend, Indemnify, and Hold Harmless** Lake Washington School District or any of its schools, Environmental and Adventure School PTO ("EAS PTO"), any of their volunteers, the bus transportation company and all event sponsors (hereinafter "Releasees") of and from any and all liability, claims, liens, demands, actions and causes of action whatsoever arising out of or related to any loss, cost, damage or injury, including death, of any person or damage to property of any kind related in any way to the Program's operations or the errors or omissions of the Program, its agents, subcontractors, volunteers, or any other person directly or indirectly employed by them, or any of them, while engaged in any activity associated with this Agreement, whether contractually or otherwise.

This Release is binding as to any other persons, including family members, heirs and executors. If I am signing on behalf of a minor, I guarantee I am duly authorized to do so. I recognize that I may not release any claims the minor may have. However, I accept full responsibility for all medical expenses, damages and/or claims incurred as a result of the minor's participation in or travels to and from the program.

Participants will be expelled from this program without refund for being willfully disobedient; possession, use or sale of tobacco, alcohol, or controlled substances; vulgarity; discussing sexual topics; harassment; stealing; gambling; fighting; leaving the ski area; or for using non-approved transportation. If the participant arrives to the bus after 6pm, the **participant and/or parents will reimburse the program for all additional costs incurred** (this is a minimum of \$100 per hour, per bus delayed).

These activities are not sponsored nor endorsed by Lake Washington School District, any of its schools, or EAS PTO. The district and EAS PTO assume no responsibility for the conduct during or safety of the activities and shall be held harmless from any cause of action, claim, or petition filed in any court or administrative tribunal arising out of the distribution of these materials including attorney's fees, judgments or awards.
